Coordinators Call Summary

Thanks to the 13 staff representing 9 study sites who attended this call.

There was all around congratulations for everyone's hard work at all sites who either added to accrual in the last month or now has IRB approval. Protocol cards have been mailed to study sites; please remember to add a label to the card with your contact information before distributing the cards. The following question was discussed:

What are the radiology requirements for bowel obstruction?
 Any indication of possible bowel obstruction is eligible for the study.

The following reminders were discussed by SWOG personnel:

- Management of different levels of patient follow-up :
 - ♦ Active follow-up is when the patient consents to receive the study-related phone calls; all patients are in active follow-up when they register to the study.
 - ♦ Passive follow-up is when the patient no longer wants to receive the study-related phone calls, but agrees to allow their data to be collected.
 - Sites must submit the S1316 Off Protocol Notice within 3 days when a patient no longer wants to be called, so that the Arizona Diet, Behavior, and Quality of Life Assessment Lab, which makes the monthly dietary recall calls, is notified.
 - ♦ Patients who have declined further phone calls and are under passive follow-up should still have their data reported, using medical records. If the patient is going to be followed at another Institution, study staff should obtain a Release of Information so you can request the patient's medical records.
 - Patients that refuse all further follow-up and no longer wish to participate in the study in any capacity must be removed from follow-up using the Consent Withdrawal form; no further data will be collected from these patients.
- Equipoise eligibility criteria: It is equipoise if it is reasonable to go either way on treatment options (surgical versus non-surgical).

Accruing patients after-hours

Patients participating in the <u>non-randomized</u> portion of the study may be registered under SWOG Policy #12. This policy specifies that registrations to the non-randomized portion of a study (1) after regular business hours (e.g., on holidays or weekends), or (2) while the site is unable to access the online registration program, may be completed by calling the Data Operations Center rather than using OPEN. To implement SWOG Policy #12 correctly, the institution must call the Data Operations Center leaving a voice mail message on the day treatment is to begin.
